## **Parking Data**

### **Service Statistics – Controlled Parking Spaces**

Shropshire Council had 4049 marked out controlled on-street and 6232 off-street parking spaces within its area (estimated where spaces are not marked) in the year April 2024 to March 2025. Of these, Shropshire Council directly provided 4353 free parking spaces, 5928 parking spaces where charges applied and 2041 spaces for Park and Ride.

### **Enforcement Statistics**

In the financial year 2024-2025 there were 17,120 Penalty Charge Notices (PCNs) issued in Shropshire. PCNs are issued to vehicles parked in contravention of a parking restriction as observed by Civil Enforcement Officers (CEOs).

Of the 17,120 PCNs issued, 9,071 were issued for higher level contraventions (£70 penalty) and 8,103 were issued for lower-level contraventions (£50 penalty).

There are three stages of the PCN appeal process – informal challenge, formal representation and appeal to the independent Traffic Penalty Tribunal.
