AND STATEMENT MODIFICATION ORDER**

**THE SHROPSHIRE COUNCIL (FOOTPATH 30 (PART)
TOWN OF MARKET DRAYTON) PUBLIC PATH DIVERSION ORDER 2023**

The above order was made on 15th June 2023. The effect of the order will be to divert

The full width of that part of FP 30 leaving point A on the Order Map at grid reference SJ 6682 3400 running in a general NNW direction on a stoned surface to point B on the Order Map at grid reference SJ 6679 3403. A distance of approximately 43 metres **onto a line** leaving point A on the Order Map at grid reference SJ 6682 3400 running in a general westerly then NNW direction on a tarmac surface with an approximate width of 2 metres to point B on the Order Map at grid reference SJ 6679 3403. A total approximate distance of 47 metres throughout its length.
