## NOTICE OF MODIFICATION ORDER

## WILDLIFE AND COUNTRYSIDE ACT 1981 DEFINITIVE MAP AND STATEMENT OF RIGHTS OF WAY FOR SHROPSHIRE

## THE SHROPSHIRE COUNCIL (FOOTPATH ADDITION, PARISH OF BUCKNELL) MODIFICATION ORDER 2025

The above-named Order made on 12<sup>th</sup> June 2025 by The Shropshire Council ("the Council") if confirmed as made, will modify the Definitive Map and Statement for the area by **adding**;

a footpath commencing from Bucknell footpath 5 at grid reference SO 3594 7388 (Order Map Point A) and then running in a general east north-east direction to grid reference SO 3610 7392 where it meets the northern boundary of the railway line, continuing in a general east north-east direction across part of the railway line to grid reference SO 3614 7394, continuing in a general south-east direction across the remainder of the railway line to grid reference SO 3615 7393 where it meets the southern boundary of the railway line, continuing in a general south-east, then east south-east direction to grid reference SO 3629 7383 where it enters woodland, continuing in a general easterly direction to grid reference SO 3639 7381 where it meets Herefordshire footpath BC1A at the County boundary (Order Map Point B). The whole route has a width of 2 metres throughout and a total distance of approximately 450 metres.

If no representations or objections are duly made to the Order, or to any part of it, or if any so made are withdrawn, the Council, instead of submitting the Order to the Secretary of State (or part of it if the Council has by notice to Secretary of State so elected under paragraph 5 of Schedule 15 to the Wildlife and Countryside Act 1981) may itself confirm the Order (or that part of the Order). If the Order is submitted to the Secretary of State for the Environment, Food and Rural Affairs in whole or in part, any representations and objections which have been duly made and not withdrawn will be sent with it.
