**THE SHROPSHIRE COUNCIL (FOOTPATH 13 PARISH OF BUILDWAS)
TEMPORARY PUBLIC PATH STOPPING UP ORDER 2025.**

This order is made by the Shropshire Council ("the Council") under section 257 and 261 of the Town and Country Planning Act 1990 because it is satisfied that it is necessary to temporarily stop up the footpath to which this order relates in order to enable development to be carried out (in accordance with planning permission granted under Part III of the Town and Country Planning Act 1990) under planning reference **24/02537/VAR-** for the variation of Condition 12 of planning permission 19/05509/MAW regarding the phased extraction of sand and gravel, associated works, and restoration, to achieve the dispatch of up to 300,000 tonnes of extracted mineral per calendar year).

BY THIS ORDER:

1. The footpath over the land shown by a bold black line on the attached map and described in Part 1 of the Schedule to this order ("the Schedule") shall be temporarily stopped up as provided by this order until 9th January 2031. Before the expiration of this period, the footpath will be restored on its original alignment to a condition not substantially less convenient to the public.

PART I

Description of site of existing path or way

The full width of FP 13 leaving Restricted Byway 16 at point A on the Order map at grid reference SJ 6459 0421 running in a general ESE then SSE direction to point B on the Order map at grid reference SJ 6481 0392. A distance of approximately 408 metres.
