

**NOTICE OF PUBLIC PATH DIVERSION AND DEFINITIVE MAP  
AND STATEMENT MODIFICATION ORDER  
TOWN AND COUNTRY PLANNING ACT 1990, SECTION 257  
WILDLIFE AND COUNTRYSIDE ACT 1981, SECTION 53(A)(2)**

**THE SHROPSHIRE COUNCIL (FOOTPATH 13Y (PART) PARISH OF SELATTYN  
& GOBOWEN) PUBLIC PATH DIVERSION ORDER 2025.**

The above order was made on 7<sup>th</sup> August 2025. The effect of the order will be to **divert**

The full width of that part of FP 13Y leaving point A on the Order map at grid reference SJ 3015 3365 running in a general westerly direction on a natural surface to the A5 at point B on the order map at grid reference SJ 2994 3365. A distance of approximately 201 metres onto a line leaving point A on the Order map at grid reference SJ 3015 3365 running in a general north westerly then south westerly direction on a 2 metre wide surfaced path to point B on the Order map at grid reference SJ 2994 3365. A distance of approximately 202 metres.
