

**NOTICE OF PUBLIC PATH DIVERSION AND DEFINITIVE MAP
AND STATEMENT MODIFICATION ORDER
TOWN AND COUNTRY PLANNING ACT 1990, SECTION 257
WILDLIFE AND COUNTRYSIDE ACT 1981, SECTION 53(A)(2)**

**THE SHROPSHIRE COUNCIL (RESTRICTED BYWAY 8 (PART), PARISH OF
WHITCHURCH RURAL)
PUBLIC PATH DIVERSION ORDER 2025.**

The above order was made on 22nd May 2025. The effect of the order will be to **divert**

The full width of RB 8 leaving point A on the Order map at grid reference SJ 5358 3892 running in a general ESE direction on a natural surface to point B on the Order map at grid reference SJ 5380 3885. A total approximate distance of 234 metres **onto a line** leaving point A on the Order map at grid reference SJ 5358 3892 running in a general SSW, ESE, south easterly then north easterly direction on a natural surface, with a width of 8 metres throughout to rejoin the Definitive line at an existing gate at point B on the Order map at grid reference SJ 5380 3885. A total approximate distance of 394 metres.

If no such representations or objections are duly made, or if any so made are withdrawn, the Council may itself confirm the order as an unopposed order. If the order is sent to the Secretary of State for the Environment, Food and Rural Affairs for confirmation any representations or objections which have not been withdrawn will be sent with the order.
