

**NOTICE OF MODIFICATION ORDER**  
**WILDLIFE AND COUNTRYSIDE ACT 1981**  
**DEFINITIVE MAP AND STATEMENT OF RIGHTS OF WAY FOR SHROPSHIRE**

**THE SHROPSHIRE COUNCIL**  
**(BRIDLEWAY ADDITION, PARISH OF ADDERLEY) MODIFICATION ORDER 2018**

The above named Order made on 21<sup>st</sup> June 2018, by The Shropshire Council (“the Council”) if confirmed as made, will modify the Definitive Map and Statement for the area by:-

adding a Bridleway from the County boundary at point A on the Order Map (SJ 6487 4094), running in a general easterly direction over Nethermost Bridge then passing through a gate (SJ 6491 4094) and then turning generally east-south-easterly over a pasture field to pass through a gate (SJ 6508 4087) where it turns in a general easterly direction following a field edge track to exit onto the County Road via a gate at point B on the Order Map (SJ 6545 4085); a total distance of approximately 597 metres with a width of 3 metres throughout.

A copy of the Order and the Order map may be seen free of charge at the Council offices at The Shirehall, Abbey Foregate, Shrewsbury during normal office hours. Copies of the Order and map may also be bought from the Shropshire Council at the above address at a cost of £6.50. Any representation or objection relating to the Order must be sent in writing to Shropshire Outdoor Partnerships, Rights of Way Mapping and Enforcement Manager, The Shirehall, Abbey Foregate, Shrewsbury, SY2 6ND, or by email to [outdoor.recreation@shropshire.gov.uk](mailto:outdoor.recreation@shropshire.gov.uk). not later than 3<sup>rd</sup> August 2018 and you are requested to state the grounds on which it is made.

If no representations or objections are duly made to the Order, or to any part of it, or if any so made are withdrawn, the Council, instead of submitting the Order to the Secretary of State (or part of it if the Council has by notice to Secretary of State so elected under paragraph 5 of Schedule 15 to the Wildlife and Countryside Act 1981) may itself confirm the Order (or that part of the Order). If the Order is submitted to the Secretary of State for the Environment, Food and Rural Affairs in whole or in part, any representations and objections which have been duly made and not withdrawn will be sent with it.
