THE SHROPSHIRE COUNCIL BRIDLEWAY 7B (PART) PARISH OF CAYNHAM PUBLIC PATH DIVERSION ORDER 2025

This Order is made by the Shropshire Council ("the Council") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Council that in the interests of the landowner of the land crossed by the bridleway described in paragraph 1 of this order it is expedient that the line of the way should be diverted.

This Order is also made under section 53A (2) of the Wildlife Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Shropshire definitive map and statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway shown or required to be shown in the map and statement.

BY THIS ORDER:

1. The public right of way over the land situated at Percys Cottage and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up on the date of confirmation of this Order and thereupon the Shropshire definitive map shall be modified by deleting from it that public right of way.

- Notwithstanding paragraph 1 of this Order statutory undertakers shall have the following rights over the land referred to in paragraph 1 above, namely:
 - Where immediately before the date on which the bridleway is diverted there is apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same right in respect of the apparatus as they then had.
- 3. There shall on the date of confirmation of this Order be a public bridleway over the land situated at Percys Cottage described in Part 2 of the Schedule and shown by a bold broken line on the map contained in this Order and thereupon the Shropshire definitive map shall be modified by adding that bridleway to it.
- 4. 3A. The Shropshire definitive statement shall be modified as described in Part 4 of the Schedule to this order.
- 5. The diversion of the bridleway shall only have effect on the date on which Shropshire Council certifies that any works required to bring the bridleway into a fit condition have been carried out.
- 6. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

Description of site of existing path or way

the full width of that part of BW 7B leaving BW 9 at point A on the Order map at grid reference SO 5872 7588 running in a general westerly direction on a natural surface, alongside Percys Cottage to point B on the Order map at grid reference SO 5885 7585. A total distance of approximately 138 metres.

PART 2

Description of site of new path or way

Leaving BW 9/BW 5 at point C on the Order map at grid reference SO 5877 7594 running in a general south easterly direction to a gate then continuing in an ESE direction to rejoin the Definitive line of BW 9 at point B on the Order map at grid reference SO 5885 7585. A distance of approximately 180 metres, on a natural surface with a width of 3 metres throughout its length.

Limitations and conditions

Gate to be installed at grid reference SO 58828 75882 to BS 5709

PART 4

Modification of Definitive Statement

Leaving BW 9/BW 5 at point C on the Order map at grid reference SO 5877 7594 running in a general south easterly direction to a gate then continuing in an ESE direction to rejoin the Definitive line of BW 9 at point B on the Order map at grid reference SO 5885 7585. A distance of approximately 180 metres, on a natural surface with a width of 3 metres throughout its length.

There is no Shropshire definitive statement for the remainder of this Right of Way


