Logically, the low est impact site for new housing w ould be the area of land surrounding Stanmore industrial estate. This w ould be low visual/environmental impact, w ith easy access to local employment on the industrial estate and on the Stourbridge Rd, and in the ideal location for commuters to Wolverhampton/Stourbridge.

Para 5.24 in the explanations section states : "Great concerns w ere raised by the local community about the concentration of development at Tasley and crossing the bypass, but at the present time the tow n has little option but to extend in a north-w est direction due to Green Belt, topographical and landscape constraints in all other directions. It is recognised that the Green Belt w ill need to be review ed in the next Local Plan review "

Review of the Green Belt allocation should have been included in the current plan - failure to do this has resulted in a heavily imbalanced plan, w ith disproportionate and damaging development in the Tasley area. This area has already been the focus of previous greenfield developments.
