Site Assessment Summary

This site is situated on the south western edge of Kinlet adjoining Little Stocks Close and the village hall. The site scores well in sustainability appraisal on proximity to bus stop and primary school. It is scores negatively on proximity to amenities and for being on agricultural land. The site scores neutrally on remaining criteria. Overall, the site's sustainability is considered to be fair based on this appraisal.

The site is considered to be a realistic option for residential development to meet the housing requirement in the village and contribute to the requirement across the Community Cluster as a whole. The whole of the site is capable of providing more than the housing target and it is considered that the land east of the B4194, south of Little Stocks Close, is the preferred part of the site for development of up to 20 dwellings. This site is contained within the boundary of the B4194 and allows for possible links into the rest of the village without crossing the B road. The site is capable of providing an appropriate mix of affordable housing to meet local needs and open market development.
