THE SHROPSHIRE COUNCIL (FOOTPATH UN1 & FP 71 (PARTS) TOWN OF SHREWSBURY) PUBLIC PATH DIVERSION ORDER 2022

This Order is made by the Shropshire Council ("the Council") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Council that in the interests of the landowner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the way should be diverted.

This Order is also made under section 53A (2) of the Wildlife Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Shropshire definitive map and statement require modification in consequence of the occurrence of an event specified in section 53 (3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway shown or required to be shown in the map and statement.

BY THIS ORDER:

1. The public right of way over the land situated to the south of Oteley Road and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up on the date that the Council certifies that works have been carried out to bring the site of the new footpath described in Part 2 of the Schedule to this Order into a fit condition for use by the public and thereupon the Shropshire definitive map shall be modified by deleting from it the public right of way to be stopped up.

- 2. Notwithstanding paragraph 1 of this Order statutory undertakers shall have the following rights over the land referred to in paragraph 1 above, namely: where immediately before the date on which the footpath is diverted there is apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same right in respect of the apparatus as they then had.
- 3. There shall on the date of confirmation of this Order be a public footpath over the land situated to the south of Oteley Road described in Part 2 of the Schedule and shown by bold broken lines on the map contained in this Order and thereupon the Shropshire definitive map shall be modified by adding that path to it.
- 3A. The Shropshire definitive statement shall be modified as described in Part 4 of the Schedule to this order.
- 4. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

Description of site of new path or way

The footpath to be created leaving point A on the Order Map (SJ 4951 1004) running as FP UN1 on a natural surface in a general north easterly then easterly direction to join FP 74, then as FP 71 running in an easterly direction to re-join the Definitive line of FP 71 at point C on the Order Map (SJ 4963 1007). A total distance of approximately 121 metres with a width of 2 metres throughout.

Modification of Definitive Statement

The footpath to be created leaving point A on the Order Map (SJ 4951 1004) running as FP UN1 on a natural surface in a general north easterly then easterly direction to join FP 74, then as FP 71 running in an easterly direction to re-join the Definitive line of FP 71 at point C on the Order Map (SJ 4963 1007). A total distance of approximately 121 metres with a width of 2 metres throughout.
