

## Joe Bloggs | Safety Plan

### Why are we creating this plan?

Joe, we are worried about your safety when out in the community. This plan is needed because there are concerns around risky associates and exploitation - and we want to keep you safe.

---

## The Safety Plan

### Joe's responsibilities

- We want you to stick to this safety plan and be open and honest with Mum, Dad and Steve your Social Worker, so we can support you with any worries.
- There is to be no substance misuse in the home and no substances to be kept within the home.

### Going out

- Please do not leave the home during the night as this may cause you to be unsafe.
- Before leaving home, let parents know where you are going and what time you will be back.
- Joe, please return home for 8pm. If you do not return, then your parents will report you missing. This is because they would be worried about you and are wanting you to always be safe.
- Joe, we are worried about you when spending time with Bill, Ted and John, as you often get pulled into activities that are risky and this is likely to make you unsafe. If we receive information to say that you are unsafe with these people, then we may have to implement stricter rules, such as no contact.
- You have recently been arrested in Shrewsbury and you have also spoken to us about spending time in Birmingham and using cocaine there, so we are worried about your safety when you are in this area. We do not want you to travel to this area, unless with family.

### Online safety

- Joe, we are worried about your online activity because some of your online actions are getting you into trouble. We want you to follow the rules around online safety that parents and professionals are putting in place to keep you safe and to prevent you getting into more trouble

- You are not to threaten people or send abusive messages online, this is crime and police will take action.
- You are not to access the telegram app because there are illegal items, including weapons and drugs, on the site and being connected to this could get you into trouble.
- Not following these rules will lead to stricter boundaries and more restrictions on your phone.

### **Katie and Andrew (parents) responsibilities**

Please use this safety plan to maintain consistency in boundaries and to direct responses to challenging behaviours or situations. Please share any information or concerns with professionals at earliest availability so we can help.

- Parents to check Joe's room frequently and report to professionals if anything concerning is found, including substances and weapons.
- Parents are not to provide Joe with alcohol whilst in Shrewsbury, as when under the influence, Joe is at heightened risk.
- Parents to check in regularly with Joe about his online activity and report any concerns to professionals so we can deal with things.
- If Joe returns home under the influence of substances, this needs to be shared with professionals.
- If Joe is spending any time outside of Shrewsbury, other than for work or with family, this needs to be shared with professionals so we can implement appropriate measures to keep him safe.

**If you are unaware or concerned about Joe's whereabouts, he needs to be reported missing to police, through calling 101. Please share that he is high risk of exploitation and open to the police exploitation team.**
