Part C: Declaration under section 31(6) of the Highways Act 1980

1. The 12th Lord Barnard and the Trustee's of W H C Vane are the owners of the land described in paragraph 4 of Part A of this form and shown edged red on the map lodged with Shropshire Council on the 28th day of September 2005.
2. On the 1st of June 2006 Lord Barnard, under his previous title of The Hon H F C Vane, deposited with Shropshire Council, being the appropriate council, a statement accompanied by a map showing my property edged red which stated that the ways shown BROWN (dashes) on that map had been dedicated as ROADS USED AS PUBLIC PATHS (R.U.P.P.s) (now RESTRICTED BYWAYS following the Countryside Rights of Way Act), the ways shown BLUE on that map had been dedicated as BRIDLEWAYS, and that the ways shown GREEN on that map had been dedicated as footpaths. No other ways had been dedicated over Lord Barnard's property.
3. On the 1st of June 2006 Lord Barnard, under his previous title of The Hon H F C Vane, deposited with Shropshire Council, being the appropriate council, a declaration dated the 22nd day of November 2005, stating that no additional ways had been dedicated as R.U.P.P.s (now restricted byways following the Countryside Rights of Way Act), bridleways, or footpaths since the deposit of the statement referred to in paragraph 2 above.
4. No additional ways have been dedicated over the land edged red on the map referenced in paragraph 1 above since the statement dated the 28th of September 2005 referred to in paragraph 2 above since the date of the declaration referred to in paragraph 3 above and at the present time Lord Barnard has no intention of dedicating any more public rights of way over the property.
