Introduction of new Co-ordinator

The 2nd Making it Real co-ordinator hasn't started in their role yet.

Sophie's new Part time Role

Sophie told the Board about her new position as a Project Co-ordinator within the Office of the Chief Executive, which she will be doing a long side her current position as Making it Real co-ordinator.

Sophie described the project she is currently working on - roll out of Technology Enabled Care (TEC) and also how she is promoting Making it Real and co-production within the new team and will keep the Board informed of any upcoming projects they may like to be involved with.

Update on all the co-production projects – Laura Tyler, Shropshire Council.

Laura shared with the board the 4 main projects:

CQC Board

Help oversee and be open and transparent in terms of what we're doing, where our challenges are.

Service Improvement Board

To make sure that information is open and transparent and to that board and information's coming back down from the board.

Dom Care

Initial discussion with Healthwatch who are at the same time wanting to do something around people who are in receipt of domiciliary care. It will be really useful to work with Healthwatch, to help frame some of the questions and some of the themes, we want to ask individuals, but also look for some of those opportunities around how we could maybe go out separately.

Care reform

The Care reform will be coming in 2025. There's a lot of communications we need to do around

ensuring that people who are self-funders, that the right information and advice is available.

We've got our digital financial assessment portal going live in October. I think there's some really good communication's that we need to be doing and we could do around that.

Question from Making it Real board member:

I was wondering, was there anything else on your list that that we could have just an update on as to where we're up to?

Answer - Laura Tyler

I can send out the list, but it is a list of commissioning activity, projects etc. What we've got on there is where we're also seeking feedback and input. You'll have the assurance that we're doing pieces of work as part of that.

We're going to put it into a calendar format. With this we'll be able to track the progress over the next two to three years. I'd suggest we can do a quarterly update at this meeting in terms of the work programme.

Question - Making it Real board member:

How do you want people to volunteer?

Could you produce a summary of what somebody would be expected to do?

Do you want one person per thing or just one person?

Answer - Laura Tyler

Sophie can put together an Expression of Interest to be sent out to the board for them to express what area they would be interested in. The EOI will include a short description of the level of involvement and what they would be expected to do.

Tanya Miles

We can absolutely have non board members attending and those sessions as long as people have had the right training and support.

Update - Co-Production Champions - Sophie Davies & Tamsin Waterhouse

Sophie and Tamsin took the group through the proposed co-produced job description for the Co-production Champions. The board has suggested that the opportunity goes out to the whole of the directorate (Adults and Childrens Social Care)

The group that co-produced the work opportunity for the Champions are to look at a when to launch the opportunity and start creating communications and a badge for staff members to have on their email signatures.

Any of the other board members that are interested in being involved, this will be included in the Expression of Interest form that will be sent out.

Update - Reablement Laura Tyler updated on Natalie McFall's behalf

What they're doing at the moment is that they're working with the inhouse START Team. START are the team that will support people either from step down or step up (which we saw cluster discharge or even prevent an admissions avoiding so step up as we describe it.) They're working with them at the moment and looking at their data and looking at their

performance, looking following people through on a customer journey to see at what point they will access, what point they'll have an assessment and what information that they need.

And then they're looking at how can we streamline that and improve it. To improve its efficiency and effectiveness and improve the outcomes for individuals.

And there's some of the wider work that we're doing around the pathway redesign and also how this fits with the work that we're doing around the demand and management capacity, which is really, really key to this. It's making sure people go through that right pathway of support.

Jane Garner has volunteered to work on the Reablement project and asked the board to send any thoughts around the project to her and she can pass them on, on behalf of the board.

Update - Service improvement Board, Tamsin Waterhouse (Shropshire Council)

We're suggesting that the board meets quarterly. And during those meetings, we have a look at all of the mechanisms that we receive feedback through, and we've got a whole list of ways that we receive feedback on services including positive feedback, it's not all about service improvement. And on the basis of that, we identify some themes which we want to address.

The plan is, with the intervening months, we hold theme specific meetings where we will pick up a theme. What can we do as an organisation to improve?

Making it Real have got experts who've got expertise, who would like to contribute to us on thinking about where's the blockages? Where's the difficulties? Why is that theme repeating and coming up?

In order to form an action plan which then gets reported back, I think we're going to call it something like the Improvement Quality Assurance and Service Development Board, but the idea is we have a board which has the oversight, but then you have some themed working groups where we actually take time to consider a particular theme or a particular issue, especially something which is recurring.

These meetings will have people present who have some knowledge or something to contribute to that so that would be experts by experience, professionals working in the field and so on where we all come together and say why is there a blockage here? Why is this thing coming up? What do we need to do differently? How can we develop improved change in order to address it?

Question - Making it Real Board member

The themes that are going to be discussed, how are they being identified? Who's identifying them?

Answer - Tamsin Waterhouse

We're just trying to imagine how it might work. But the way I see it, we will report into a board with all of the feedback which we've had over the last quarter, with compliments, complaints and comments we've had. I'm envisaging there will be a report into the board saying this is what's happened in the last quarter. This is for feedback we've received through the various different mechanisms. And then the discussion about what we want to focus on next, I'm seeing it as being quite organic.

The themed meetings are for staff, for people who are involved, Experts by experience, for us all to come together and say what can we do? What can we do differently and what do we understand? Give us opportunity to just take some proper time to try to unpick what's going on.

Question - Making it Real Board member.

How will you use the 'I' and 'We' statements in the group?

Answer - Tamsin Waterhouse

There will be an action plan. We have an action plan saying what we're going to be doing differently and that has to be reported to the board and we need to make sure that we're acting on it and looking for impact.

The safeguarding board are doing, which we're doing as well now, is in the action plans creating impact. It's no good doing ABCD unless it has a positive impact for the people - we're here to serve and for good outcomes. And how we measure impact... we can think about the 'I' and 'we' statements. So that might be a really good place for it to be.

Update - Co-Production workshops with Clenton – Laura Tyler, Shropshire Council Laura feedback to the board about the main themes that came out of the co-production workshops and how they are being addressed and developed.

We talked about robust feedback and loop and channels for people to talk about their stories, which has been a bit of a repeat conversation that we've had at this board many times. We are developing the Service Improvement Board and a lot of work has been done on the Making it Real webpages to show people how they can get involved, provide feedback to the board.

We talked about relationship building, retrace and putting people on an equal setting. Sophie is going to talk about the three documents she has started pulling together to help build relationships and give us a clear focus.

Policies

Sophie took the board through the three policies (attached) and asked for feedback and also volunteer to help develop the three documents.

West Midlands ADASS (Association of Directors of Adult Social Care) have produced a recipe for co-production (attached) developed by the regional co-production working group with ADASS West Midlands. Sophie asked for feedback on this document and how it could be incorporated with the co-production framework?

It was agreed to have all three documents finished by December and look at having a coproduction event to launch the documents and also the Co-production Champion opportunities.

The board suggested asking all the council's partnership boards if any of their Experts by Experience would be interested in assisting with the three documents on a voluntary basis.

Adult Social Care in Action in Shropshire – Michelle Williams, Shropshire Council Michelle Williams shared Daniel's story with the board, the Board appreciated hearing what is being done on the ground to support local residents. Daniel's full story will be featured in the 2024 Local Account

Shropshire's Local Directory – Attach Poster

Sophie made the board aware of the Shropshire Local Directory - QUBE.

Stewart Smith explained, it's not just a directory of social care services. It's the community directory, it's got all sorts of really useful information that people can engage in, in their local communities. Develop friendships, relationships, all those kinds of things as well as the idea of social care. It's about supporting people, giving people access to what is going on around them every day.
