DEFINITIVE MAP AND STATEMENT OF RIGHTS OF WAY FOR SHROPSHIRE

THE SHROPSHIRE COUNCIL (FOOTPATH 7 (PART) DELETION AND ADDITION, PARISH OF ALVELEY) MODIFICATION ORDER 2021

This Order is made by The Shropshire Council ("the Council") under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the Council that the Shropshire Definitive Map and Statement require modification because in accordance with the provisions of Section 53(3)(c)(i) and (iii) the Council has discovered evidence which (when considered with all other relevant evidence available to them) shows -

- (i) that a right of way which is not shown on the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, a restricted byway or, subject to section 54A, a byway open to all traffic and
- (ii) that there is no public right of way over the land shown in the map and statement as a highway of any description, or any other particulars contained in the map and statement require modification.

The Council hereby order that:-

1. For the purpose of this Order the relevant date is 18th March 2021.
2. The Shropshire Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as The Shropshire Council (Footpath 7 (part) Deletion and Addition, Parish of Alveley) Modification Order 2021.

SCHEDULE

PART I

Modification of Definitive Map

Description of path or way to be deleted

That part of Footpath 7 to be extinguished commences at Point A (SO7865 8792) on the Order Map and runs in a general WNW direction through the gardens of Greenacres and The School House to Point B (SO 7854 8795) on the Order Map. A total distance of approximately 106 metres.

Description of path or way to be added

That part of Footpath 7 to be added commences at Point C (SO 7866 8797) on the Order Map from the County Road runs in a general NNE direction then easterly direction, to Point B (SO 7854 8795) on the Order Map. A total distance of approximately 118 metres, with a width of 2 metres throughout.

PART II

Modification of Definitive Statement

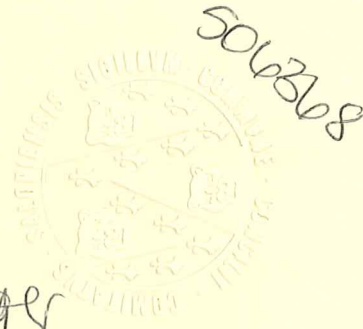
That part of footpath 7 to be added commences at point C (SO 7866 8797) from the County Road runs in a general NNE direction then easterly direction, to point B (SO 7854 8795) on the order plan. A total distance of approximately 118 metres, with a width of 2 metres throughout.
