# **Registration Form**

Shropshire Council has commissioned the Actio Consortium to manage the All In activity programme on its behalf. The council and the consortium are co-funders in the All In activity programme. The Council remains responsible for the All In registration process.

The Actio Consortium consists of Energize Shropshire Telford and Wrekin (STW) and Shropshire Parent Carer Council (PACC). They are responsible for managing and commissioning the activities and services that make up the All In activity programme from 1<sup>st</sup> April 2025 until 31<sup>st</sup> March 2026. The council has a contract with Energize (STW), on behalf of the consortium.

The Actio Consortium aims to deliver a joined-up programme of quality activity and support for children and young people with Special Educational Needs and Disabilities (SEND) and their families, building a sense of community and achievement. Actio is also responsible for promoting and monitoring All In activities. They will work with children, young people and their families to ensure the programme responds positively to feedback and comment. By completing this application form you are agreeing to share your information with both Shropshire Council and the Actio Consortium (please see privacy notice for further details about data collection, management and use).

All In Short Breaks are leisure activities, specifically commissioned for children (0-18) with disabilities (or additional needs that could be linked to a disability) funded by Shropshire Council and are part of the Council's Early Help offer. The All In programme is part of the wider Shropshire Short Break offer for children and young people with disabilities. - 2) The Equality Act 2010, refers to disability as having a "physical or mental impairment, which has a substantial and long term effect on their ability to carry out day-to-day activities." This may include a physical or learning disability, a hearing or visual impairment. It includes children who have moderately to severely challenging behaviour as a result of their learning disability or autism. It also includes children who have complex needs and who may have palliative, lifelimiting or a life-threatening condition.

# Section 4 – How we will use information about you and your child

# The Children's Disability Register

Shropshire Council gathers essential information about children with disabilities who live in the county. This helps us to understand families' needs and demands and also gather information about who can access Short Breaks. This helps us to plan future Short Breaks. It also allows us to keep in touch with families about the All In programme and share other information that may be useful.

The council uses a Children's Disability Register to record this information. It is the council's duty to have a register like this (Children Act 1989). The register is a list which holds names and basic information about children with disabilities, special or additional needs.

The information held on the register is confidential and secure. It conforms to the Data Protection Act 2018. Only authorised workers as described in our Privacy Notice can access the information. It will not be shared with other individuals or organisations without your consent.

Inclusion on the register is voluntary. You can request that your child is removed from the register at any time. We believe most parents and carers will see the benefits and want their child to be included because it will:

- help us to identify the needs of children with disabilities in general and plan appropriate services for them;
- ensure that services across social care, education and health are aware of your child and his/her needs;
- help us to plan for your child's future needs and assist in the transition to adulthood;
- enable us to keep you up-to-date about our services, through regular updates, newsletters and bulletins.

# How do we collect information from you and for what purpose?

The council is legally required to take the needs and preferences of families into account when planning services. (The Breaks for Carers of Disabled Children Regulations 2011)

We collect information from you when you complete this form for the purpose/s of;

- Confirming eligibility to participate in the All In activity programme,
- Understanding the needs and preferences of your child accessing this service, so that we can better plan future services,
- Letting you know about activities and future developments.

#### Who do we share this information with?

We will share your information with the following Council teams;

- The Council's Disabled Children's Team
  - The reason we need to share this information with the Disabled Children's Team is to fully understand all the services accessed by a family and to take this into account when planning support.
- The Council's Special Educational Needs Team (SEN Team)

  The reason we need to share this information with the SEN Team is to enable SEND related information to be shared with you.

We will share your information with the following third party;

- Energize Shropshire Telford and Wrekin (Energize STW) on behalf of the Actio Consortium
  - Information will be shared where your child is eligible to be a member of All In.

- If your child is not eligible, but you have consented to Shropshire Council sharing information.

The council has a contract with Energize STW on behalf of the Actio consortium. The consortium will develop and deliver the All-in Short Breaks programme in Shropshire until 31st March 2026.

The other partner in the Actio consortium are Shropshire Parent Carer Council (PACC).

The reason we need to share this information with Energize STW and its consortium partners is so that they can

- o understand the needs and preferences of children and young people with disabilities/additional needs in Shropshire and to take these into account when setting up the All In activities.
- o get in touch with you about upcoming activities.
- help families access activities.
- o request feedback on existing activities to improve the All-in programme.

We may also share your information with the following third parties

Statutory agencies, such as the Police and National Fraud Authority.
 The reason we may share your information with these statutory agencies would be in line with our legal obligations and/or in completion of our public tasks.

We will not sell or rent your information to any other third parties.

We will not share your information with any other third parties for marketing purposes.

Shropshire Council will dispose of the information safely;

- When your child reaches 18 years of age
- If your child moves out of the Shropshire Council area
- Your child does not attend an All In activity within a 12 month period
- If we ask you to complete a new registration form in order to review eligibility and this is not returned. If this happens, then we would write and advise you of this.
- If you request this because All In membership is no longer required.
- For any other reason that means your child is no longer eligible to participate in All In activities.



# What happens next

If this is the first application you have made to register for All In, you will be contacted by telephone by Shropshire Council to discuss your application and to offer any further advice and information that would be useful to you or answer any questions that you might have.

If you are renewing your application for All In membership we may contact you if there are further questions we need to ask you.

- Your All In application form will be checked to ensure that your child or young person is eligible.
- If you are eligible, Shropshire Council will send you an All In membership number.
- Your information will be added to the Children with Disabilities Register (if you have agreed to this).
- If you gave consent, your details will be passed to Energize STW. Energize STW will share your information with its consortium partners for the reasons outlined in their Privacy Statement attached. Your information will allow the consortium to create an All-in Passport, for you to use when booking onto activities. You can use the passport to introduce your child, their interest and their support needs to providers, so that they can respond appropriately to your child's needs. For some activities the provider may need to request further specific information to ensure that your child can participate safely in sessions.

Once you have received your new All In membership number, you can then contact providers to book activities.
