THE SHROPSHIRE COUNCIL (BRIDLEWAY ADDITION, PARISH OF ADDERLEY) MODIFICATION ORDER 2018

This Order is made by The Shropshire Council ("the Council") under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the Council that the Shropshire Definitive Map and Statement require modification because in accordance with the provisions of Section 53(3)(c)(i) and (ii) the Council has discovered evidence which (when considered with all other relevant evidence available to them) shows -

- (i) that a right of way which is not shown on the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, a restricted byway or, subject to section 54A, a byway open to all traffic

The Council have consulted with every local authority whose area includes the land to which this Order relates.

The Council hereby order that:-

1. For the purpose of this Order the relevant date is 1st June 2018
2. The Shropshire Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as The Shropshire Council (Bridleway Addition, Parish of Adderley) Modification Order 2018.

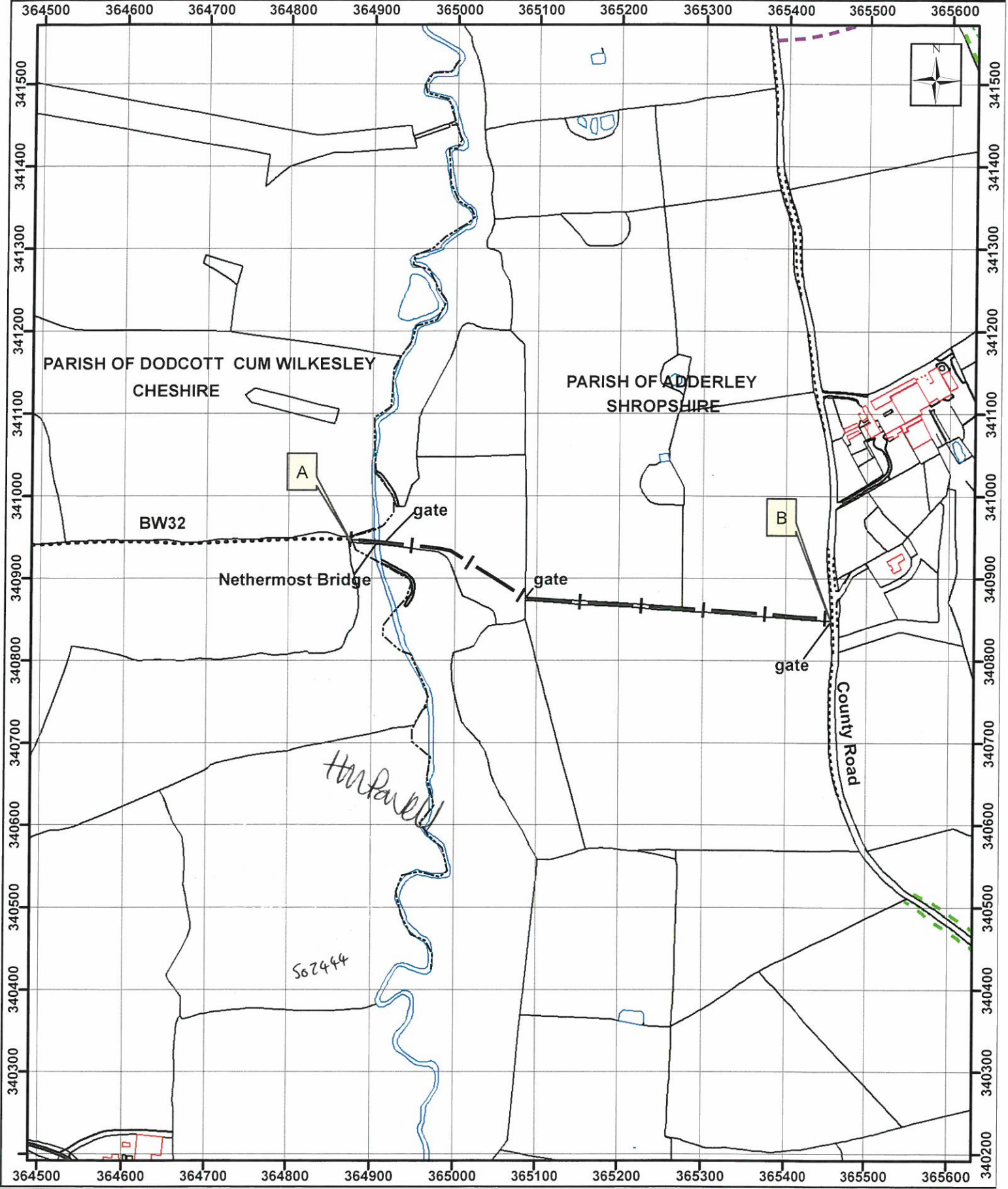
