

**THE SHROPSHIRE COUNCIL
(PROHIBITION AND RESTRICTION OF WAITING AND PARKING
PLACES) (CONSOLIDATION) ORDER 2009 (SHREWSBURY ROAD,
CHURCH STRETTON) (AMENDMENT) ORDER 2026**

On 6 August 2026 Shropshire Council made an order to introduce the following parking restrictions on Shrewsbury Road, Church Stretton:

No Waiting or Loading At Any Time

Shrewsbury Road (east side)	From a point 32 metres north of its junction with Churchill Road to a point 20 metres north of the northern property boundary of no. 50 Shrewsbury Road, Church Stretton.
Shrewsbury Road (east side)	From a point 71 metres north of the northern property boundary of no. 50 Shrewsbury Road, Church Stretton to a point 92 metres north of that same boundary.
Shrewsbury Road (east side)	From a point 118 metres north the northern property boundary of no. 50 Shrewsbury Road, Church Stretton to a point 121 metres north of that same boundary.
Shrewsbury Road (east side)	From a point 1 metre south of the property boundary of no. 63 and no. 65 Shrewsbury Road to a point 13 metres north of that same boundary.
Shrewsbury Road (west side)	From a point 75 m north of its junction with Carding Mill Valley to a point 13 metres north of the property boundary of no. 63 and no. 65 Shrewsbury Road.

Prohibition of Stopping on School Keep Clear markings

Shrewsbury Road (east side)	From a point 20 metres north of the northern property boundary of no. 50 Shrewsbury Road, Church Stretton to a point 71 metres north of that same boundary.
Shrewsbury Road (east side)	From a point 92 metres north of the northern property boundary of no. 50

Shrewsbury Road, Church Stretton to a point 118 metres north of that same boundary.

Shrewsbury Road
(east side)

From a point 186 metres north of the northern property boundary of no. 50 Shrewsbury Road, Church Stretton to a point 1 metre south of the property boundary of no. 63 and no. 65 Shrewsbury Road.

Limited waiting for buses only Mon-Fri 8am-6pm

Shrewsbury Road
(east side)

From a point 121 metres north the northern property boundary of no. 50 Shrewsbury Road, Church Stretton for a distance of 65 metres in a northerly direction.

These changes will come into effect on 14 August 2026.

A copy of the order may be examined during normal office hours (8:45am-5:00pm Monday to Thursday, and 8:45am-4:00pm on Fridays) at Shropshire Council, The Guildhall, Frankwell, Shrewsbury.

If you wish to question the validity of the Order, or any provisions in it, on the grounds that they are not within the powers conferred by The Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, you may, within six weeks from 6 August 2026, apply for that purpose to the High Court.
