DEFINITIVE MAP AND STATEMENT OF RIGHTS OF WAY FOR SHROPSHIRE

THE SHROPSHIRE COUNCIL (BRIDLEWAY ADDITIONS, PARISHES OF COUND & PITCHFORD) MODIFICATION ORDER 2024

This Order is made by The Shropshire Council ("the Council") under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the Council that the Shropshire Definitive Map and Statement require modification because in accordance with the provisions of Section 53(3)(c)(i) the Council has discovered evidence which (when considered with all other relevant evidence available to them) shows -

that a right of way which is not shown on the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, a restricted byway or, subject to section 54A, a byway open to all traffic

The Council hereby order that:-

- 1. For the purpose of this Order the relevant date is 19th January 2024.
- 2. The Shropshire Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the maps attached to the Order.
- 3. This Order shall take effect on the date it is confirmed and may be cited as The Shropshire Council (Bridleway Additions, Parishes of Cound & Pitchford)

 Modification Order 2024.

SCHEDULE

PART I

Modification of Definitive Map

Description of paths or ways to be added

i) Bridleway Addition - Order Map 1

A Bridleway to be added from Point A on Order Map 1 where it leaves the County Road at grid reference SJ 5301 0363 running in an east south easterly direction along a hedged track within the Parish of Pitchford. It then crosses the Piller Brook into Cound Parish. Continuing to Golding where it becomes a surfaced driveway at grid reference SJ 5433 0344. It then turns to run in an east north easterly direction and continues to Point B on the Order Map grid reference SJ 5447 0349 where it meets the County Road. The route has a width varying between 6 – 10 metres throughout and a length of approximately 1470 metres.

ii) Bridleway Addition - Order Map 2

A Bridleway to be added from Point A on Order Map 2 grid reference SJ 5530 0482 at Upper Cound where it leaves the County Road and runs in a general east north easterly direction along a wide stoned track. It passes a Cottage and descends into a sunken lane. It then crosses Cound Brook by way of a culvert and bridge and then climbs to Point B on Order Map 2 grid reference SJ 5567 0503 where it meets the County Road. The route has a width varying between 2 – 6 metres throughout and a length of approximately 433 metres.

Modification of Definitive Statement

Description of paths or ways to be added

i) Bridleway Addition - Order Map 1

A Bridleway to be added from Point A on Order Map 1 where it leaves the County Road at grid reference SJ 5301 0363 running in an east south easterly direction along a hedged track within the Parish of Pitchford. It then crosses the Piller Brook into Cound Parish. Continuing to Golding where it becomes a surfaced driveway at grid reference SJ 5433 0344. It then turns to run in an east north easterly direction and continues to Point B on the Order Map grid reference SJ 5447 0349 where it meets the County Road. The route has a width varying between 6 – 10 metres throughout and a length of approximately 1470 metres.

ii) Bridleway Addition - Order Map 2

A Bridleway to be added from Point A on Order Map 2 grid reference SJ 5530 0482 at Upper Cound where it leaves the County Road and runs in a general east north easterly direction along a wide stoned track. It passes a Cottage and descends into a sunken lane. It then crosses Cound Brook by way of a culvert and bridge and then climbs to Point B on Order Map 2 grid reference SJ 5567 0503 where it meets the County Road. The route has a width varying between 2 – 6 metres throughout and a length of approximately 433 metres.




