Who we are?

How do we collect information from you?

We collect information from you when you visit the Shropshire Council website also when you contact us in writing, complete a form, speak to us on the phone, by email or any other type of electronic communication, or talk to us face to face.

What types of information do we collect from you?

We collect different categories of information about you, depending on the service you want from us and/or the reason why we need to process information relating to you. This could be personal information (for example your name and address), or other more sensitive data that we would only collect and use in very particular circumstances that are set out in law.

How is your information used?

- To contact you about a booking for events, exhibitions and services
- To process payments or charges,
- To carry out our obligations arising from any contracts entered into by you and us.
- To notify you of changes to our services
- To send you communications which you have requested and that may be of interest.
- Object donors will have their contact information added to our collections management database to help us deal with your request and/or to enhance the data we hold about our collections
- To enable us to fulfil our legal obligations in relation to our Collection Management Records
 - We may use your information to:

 - Help record and interpret the historical significance of the object/s in question
 - Carry out our obligations such as the return of objects on loan
 - Notify you of changes to our services

Research and statistics

Anonymised and pseudonymised data may be used for research & statistical purposes. Any data collected may be used for research and statistical purposes that are relevant and compatible with the purpose that the data was collected for.

Who has access to your information?

Collection Management Records

We may share your information with the following third parties for the reasons detailed;

- Portable Antiquities Scheme Where you have agreed that an object/s data can be added to the Portable Antiquities Scheme Database
- Internally with other departments such as Shropshire Archives or the Historic Environment Team Where an item is to be transferred into their care and/or relates to their records.
- Statutory agencies, such as the Police, National Fraud Authority We may share your information with statutory agencies in line with our legal obligations and/or in completion of our public tasks.

Where a researcher requests your information we will always seek your permission first.

We will not sell or rent your information to third parties. We will not share your information with third parties for marketing purposes.

What are your rights in relation the personal data we process?

Access – you can request copies of any of your personal information that is held by the Council.

Rectification – you can ask us to correct any incorrect information.

Deletion – you can ask us to delete your personal information. The Council can refuse to delete information if we have a lawful reason to keep this.

Portability – you can ask us to transfer your personal data to different services or to you in some circumstances.

Right to object or restrict processing – you have the right to object to how your data is being used and how it is going to be used in the future.

Right to prevent automatic decisions – you have the right to challenge a decision that affects you that has been made automatically without human intervention, for example an online form with an instant decision.

How long will we keep your information for?

We keep and dispose of all records in line with our corporate retention schedule. We will comply with Data Protection legislation in regard to how long we keep your data.

In the case of object acquisitions this information is held in perpetuity as part of the object's accession record.

What security precautions in place to protect the loss, misuse or alteration of your information?

We are strongly committed to data security and will take reasonable and appropriate steps to protect your personal information from unauthorised access, loss, misuse, alteration or corruption. We have put in place physical, electronic, and managerial procedures to safeguard the information you provide to us. However, we cannot guarantee the security of any information you transmit to us. We recommend that you take every precaution to protect your personal information.
