# Parking Annual Report 2019/2020

### **Service Statistics – Controlled Parking Spaces**

Shropshire Council had 12,603 marked out controlled on and off street parking spaces within its area (estimated where spaces are not marked) in the year April 2019 to March 2020. Of these, Shropshire Council directly provided 4,497 free parking spaces and 8,106 parking spaces where charges applied.

### **Enforcement Statistics**

In the financial year 2019/20 there were 18,391 Penalty Charge Notices (PCNs) issued in Shropshire. PCNs are issued to vehicles parked in contravention of a parking restriction as observed by Civil Enforcement Officers (CEOs).

Of the 18,391 PCNs issued, 10,090 were issued for higher level contraventions (£70 penalty) and 8,301 were issued for lower level contraventions (£50 penalty).

As part of the civil enforcement of parking, PCNs can be appealed if the recipient believes they have mitigating circumstances that warrant the cancellation of the PCN. There are three stages of the PCN appeal process – informal challenge, formal representation and appeal to the independent Traffic Penalty Tribunal. The total surplus figure of £3,101,685.65 includes a deficit of £4,503.06 incurred through the operation of parking enforcement activities, including the PCN appeal process.

The surplus (before parking enforcement activities) of £3,106,188.71 was used in 2019/20 to offset expenditure incurred on subsidised public transport of £2,989,703.54 and maintaining the highway £116,485.17.
