The West Midlands SEND and AP Change Programme is an initiative led by the Department for Education to improve the support system for children and young people with special educational needs and disabilities (SEND). The programme aims to enhance outcomes for these children, improve family experiences, and ensure financial sustainability. The numbers of days' work provided by contracted individuals or companies will be open to negotiation and will be driven by capacity and need.
