

**NOTICE OF MODIFICATION ORDER**  
**WILDLIFE AND COUNTRYSIDE ACT 1981**  
**DEFINITIVE MAP AND STATEMENT OF RIGHTS OF WAY FOR SHROPSHIRE**  
**THE SHROPSHIRE COUNCIL**  
**(FOOTPATH 7 (PART) DELETION AND ADDITION, PARISH OF**  
**ALVELEY) MODIFICATION ORDER 2021**

The above named Order made on 18<sup>th</sup> March 2021 by The Shropshire Council (“the Council”) if confirmed as made, will modify the Definitive Map and Statement for the area by:-

**deleting** part of Footpath 7 commencing at Point A on the Order Map Grid Reference SO 7865 8792 and running in a general WNW direction through the gardens of Greenacres and The School House to Point B on the Order Map Grid Reference SO 7854 8795. A total distance of approximately 106 metres; and  
**adding** part of Footpath 7 from Point C on the Order Map Grid Reference SO 7866 8797 from the County Road running in a general NNE direction then easterly direction, to Point B Grid Reference SO 7854 8795 on the Order Map. A total distance of approximately 118 metres, with a width of 2 metres throughout.

If no representations or objections are duly made to the Order, or to any part of it, or if any so made are withdrawn, the Council, instead of submitting the Order to the Secretary of State (or part of it if the Council has by notice to Secretary of State so elected under paragraph 5 of Schedule 15 to the Wildlife and Countryside Act 1981) may itself confirm the Order (or that part of the Order). If the Order is submitted to the Secretary of State for the Environment, Food and Rural Affairs in whole or in part, any representations and objections which have been duly made and not withdrawn will be sent with it.
