

**NOTICE OF PUBLIC PATH EXTINGUISHMENT AND  
DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER**

**HIGHWAYS ACT 1980  
WILDLIFE AND COUNTRYSIDE ACT 1981**

**THE SHROPSHIRE COUNCIL (FOOTPATH 85, PARISH OF MYDDLE, BROUGHTON AND  
HARMER HILL) PUBLIC PATH EXTINGUISHMENT ORDER 2018**

The above named order made on 25<sup>th</sup> October 2018 by the Shropshire Council (“the Council”) under section 118 of the Highways Act 1980, will **extinguish**

the full width of Footpath 85, Myddle, Broughton and Harmer Hill, to be extinguished from point A on the Order Map (SJ 4620 2534) where it leaves the county road running in a general north easterly direction across agricultural land to point B on the Order Map (SJ4639 2551); a total distance of approximately 273 metres.

A copy of the order and the order map and an explanatory statement have been placed and may be seen free of charge at the Council offices at The Shirehall, Abbey Foregate, Shrewsbury during normal office hours or via the Council’s website at

Please state the grounds on which they are made.

If no such representations or objections are duly made, or if any so made are withdrawn, the Council may confirm the order as an unopposed order. If the order is sent to the Secretary of State for the Environment, Food and Rural Affairs for confirmation any representations and objections which have not been withdrawn will be sent with the order.
