ORDER, 1965

The County Council of the Administrative County of Salop in exercise of their powers under Section 34 of the Town and Country Planning Act, 1962, and Regulation 10 of the Town and Country Planning (Control of Advertisements) Regulations, 1960, after consultation with all the councils of the county districts in the County and with neighbouring local planning authorities hereby make the following Order:-

1. The whole of the Administrative County of Salop as shown on Map A attached to this Order with the exception of those parts thereof shown approximately hatched black on Map A and more particularly delineated on Maps Nos. 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18 and 19 annexed to this Order and referred to in the Schedule hereto is hereby defined as an area of special control for the purposes of the said Town and Country Planning (Control of Advertisements) Regulations, 1960.
2. This Order may be cited as The Salop County Council (Area of Special Control) Order, 1965.

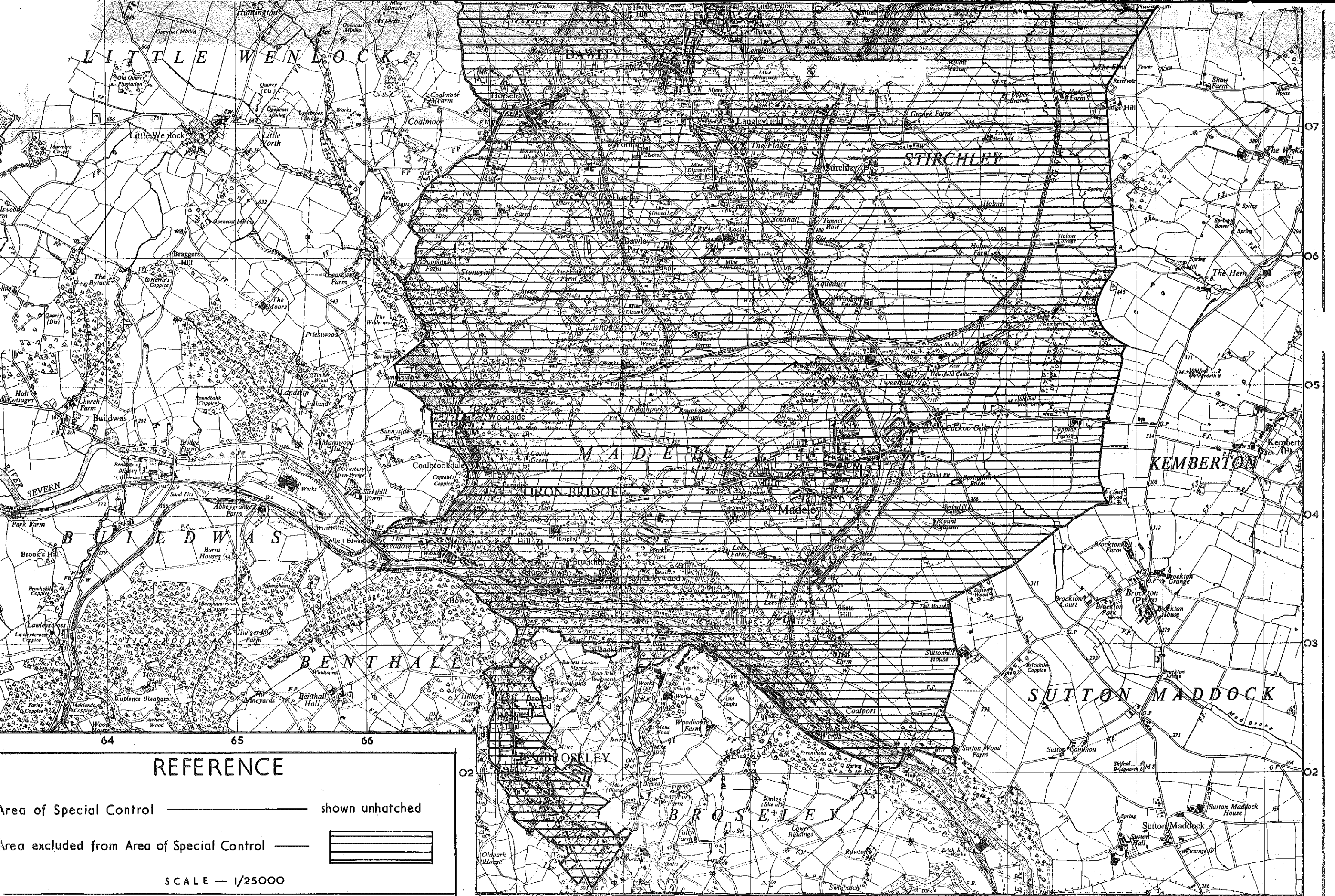

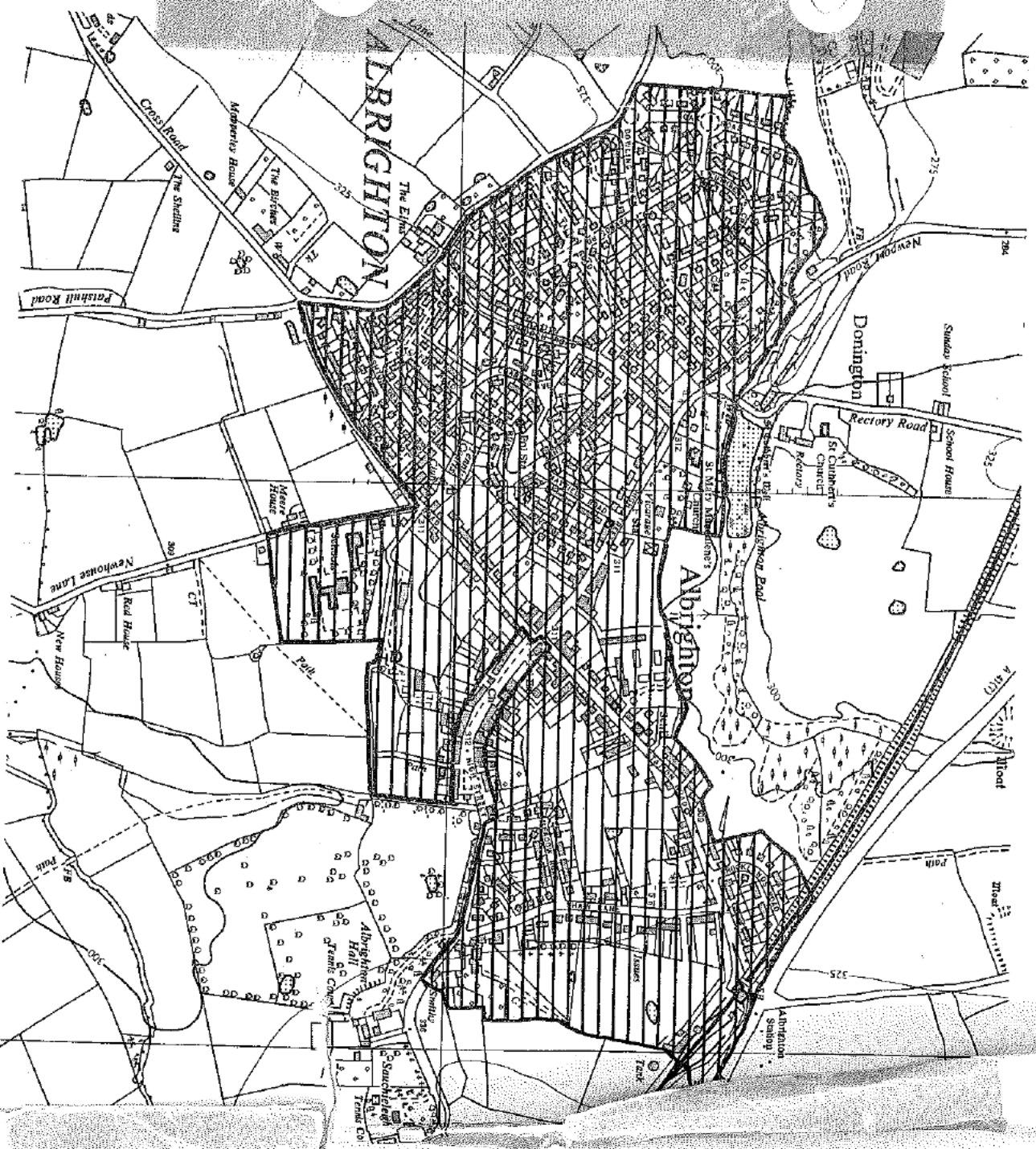
