**THE SHROPSHIRE COUNCIL (FP 177 (PART) PARISH OF BARROW) PUBLIC
PATH DIVERSION ORDER 2025.**

This Order is made by the Shropshire Council ("the Council") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Council that in the interests of the landowner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the way should be diverted.

This Order is also made under section 53A (2) of the Wildlife Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Shropshire definitive map and statement require modification in consequence of the occurrence of an event specified in section 53 (3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway shown or required to be shown in the map and statement.

BY THIS ORDER:

1. The public right of way over the land situated at Hill View Farm, and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up on the date that the Council certifies that works have been carried out to bring the site of the new footpath described in Part 2 of the Schedule to this Order into a fit condition for use by the public and thereupon the Shropshire definitive map shall be modified by deleting from it the public right of way to be stopped up.

2. Notwithstanding paragraph 1 of this Order statutory undertakers shall have the following rights over the land referred to in paragraph 1 above, namely: where immediately before the date on which the bridleway is diverted there is apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same right in respect of the apparatus as they then had.

3. There shall on the date of confirmation of this Order be a public footpath over the land at Hill View Farm, described in Part 2 of the Schedule and shown by bold broken lines on the map contained in this Order and thereupon the Shropshire definitive map shall be modified by adding that path to it.

3A. The Shropshire definitive statement shall be modified as described in Part 4 of the Schedule to this order.

4. The diversion of the footpath shall only have effect on the date on which Shropshire Council certifies that any works required to bring the footpath into a fit condition have been carried out.

5. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

SCHEDULE

PART I

Description of site of existing path or way

The full width of that part of Footpath 177 leaving the County Road at point A on the Order map at grid reference SO 6511 9858 running in a general WSW direction along the access track to a kissing gate, then in a general SSE then WSW direction through a kissing gate, passing close to the wood yard buildings into the adjoining field through a kissing gate. From here the footpath runs in a general south westerly direction to a kissing gate at point B on the Order map at grid reference SO 6469 982.

The total length of the route to be extinguished measures approximately 592 metres and is subject to four gates.

PART 2

Description of site of new path or way

A Footpath to be created leaving from the County Road at a gate at Point A on the Order Map at grid reference SO 65119858 running in a general SSW direction to a gap between trees in the field boundary, it then turns in a general WSW direction to an existing kissing gate at point B on the Order Map at grid reference SO 64699824. The footpath to be created passes over natural surface throughout.

The total length of the route to be created is approximately 630 metres, with a minimum width of 2 metres throughout.

The route will be subject to 2 gates in total.

PART 3

Limitations and conditions

Gates at grid references SO 65119858 and SO 64699824, both to BS 5709

PART 4

Modification of Definitive Statement

A Footpath to be created leaving from the County Road at a gate at Point A on the Order Map at grid reference SO 65119858 running in a general SSW direction to a gap between trees in the field boundary, it then turns in a general WSW direction to an existing kissing gate at point B on the Order Map at grid reference SO 64699824. The footpath to be created passes over natural surface throughout.

The total length of the route to be created is approximately 630 metres, with a minimum width of 2 metres throughout.

The route will be subject to 2 gates in total.
