

## PUBLIC PATH EXTINGUISHMENT AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER

## HIGHWAYS ACT 1980 WILDLIFE AND COUNTRYSIDE ACT 1981

## THE SHROPSHIRE COUNCIL (FOOTPATH UN2, PARISH OF WORTHEN WITH SHELVE) PUBLIC PATH EXTINGUISHMENT ORDER 2025.

This order is made by The Shropshire Council ("the Council") under section 118 of the Highways Act 1980 ("the 1980 Act") because it appears to the Council that the footpath described in paragraph 1 below is not needed for public use.

This Order is also made under section 53A (2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Shropshire definitive map and statement require modification in consequence of the occurrence of the event specified in section 53 (3)(a)(i) of the 1981 Act, namely, the stopping up (as authorised by this Order) of a highway hitherto shown or required to be shown in the map and statement.

#### BY THIS ORDER:

The public right of way over the land situate at Heather House in the Parish of Worthen with Shelve shown by a continuous bold line on the map attached to this order and described in Part 1 of the Schedule to this order shall be extinguished on the date of confirmation of this order and thereupon the Shropshire definitive map shall be modified by deleting from it that public right of way, and upon the occurrence of the extinguishment the Shropshire definitive map shall be modified by deleting from it that public right of way, and the definitive statement shall be modified as described in Part 2 of the Schedule to this order.

1. Notwithstanding paragraph 1 of this order statutory undertakers shall have the following rights over the land referred to in paragraph 1 above, namely:

\* Where immediately before the date on which the footpath is extinguished there is apparatus under, in, on, over, along or across them belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same right in respect of the apparatus as they then had.

#### **Description of Public Right of Way Extinguished**

The full width of Footpath UN2 from Point A on the order map at grid reference SO 3577 9741 running in a general south easterly direction through woodland for approximately 123 metres to meet the County Road at Point B on the Order map at grid reference SO 3565 9737.


