THE SHROPSHIRE COUNCIL (BRIDLEWAY UN1 (PART), PARISH OF CHESWARDINE) PUBLIC PATH DIVERSION ORDER 2020

This Order is made by the Shropshire Council ("the Council") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Council that in the interests of the landowner of the land crossed by the bridleway described in paragraph 1 of this order it is expedient that the lines of the ways should be diverted.

This Order is also made under section 53A (2) of the Wildlife Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Shropshire definitive map and statement require modification in consequence of the occurrence of an event specified in section 53 (3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway shown or required to be shown in the map and statement.

BY THIS ORDER:

1. The public right of way over the land situated at Lipley Heath Farm and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up on the date of confirmation of this order and thereupon the Shropshire definitive map shall be modified by deleting from it that public right of way.

- 2. Notwithstanding paragraph 1 of this Order statutory undertakers shall have the following rights over the land referred to in paragraph 1 above, namely: Where immediately before the date on which the bridleway is diverted there is apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same right in respect of the apparatus as they then had.
- 3. There shall on the date of confirmation of this Order be a public bridleway over the land situated at Lipley Heath Farm described in Part 2 of the Schedule and shown by bold broken lines on the map contained in this Order and thereupon the Shropshire definitive map shall be modified by adding that path to it.
- 3A. The Shropshire definitive statement shall be modified as described in Part 4 of the Schedule to this order.
 - 4. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

SCHEDULE

PART I

Description of site of existing path or way

The full width of that part of Bridleway UN1 Cheswardine, from point A on the order map (SJ 7448 3180), where the route leaves the County road, running in a general easterly direction along the access to Lipley Heath Farm continuing to run through the yard and through gates to point B on the order map (SJ 7458 3180); a total distance of approximately 98 metres.

PART 2

Description of site of new path or way

The bridleway to be created commences at Point C (SJ 7448 3182) on the order map, leaving the County Road at a bridleway gate and passing into a pasture field and running in an easterly, south easterly then easterly direction across the field to Point B (SJ 7458 3181) on the order map at a bridleway gate. A total distance of approximately 105 metres, with a width of 3 metres throughout.

Limitations and conditions

Bridleway Gate at GR SJ 7448 3182 to BS 5709 Bridleway Gate at GR SJ 7458 3181 to BS 5709

PART 4

Modification of Definitive Statement

The bridleway to be created commences at Point C (SJ 7448 3182) on the order map, leaving the County Road at a bridleway gate and passing into a pasture field and running in an easterly, south easterly then easterly direction across the field to Point B (SJ 7458 3181) on the order map at a bridleway gate. A total distance of approximately 105 metres, with a width of 3 metres throughout.

There is no Shropshire definitive statement for the remainder of Bridleway UN1 Cheswardine
