THE SHROPSHIRE COUNCIL (FP 5 (PART) & FP 5Y PARISH OF SHERIFFHALES) PUBLIC PATH DIVERSION ORDER 2025.

The above named order made on 16th January 2025 by the Shropshire Council ("the Council") under section 119 of the Highways Act 1980 and section 53A(2) of the Wildlife and Countryside Act 1981, will divert the full width of FP 5 leaving point A on the Order map at grid reference SJ 7786 1352 running in a general easterly direction as FP 5 then as FP 5Y to the A41 at point B on the Order map at grid reference SJ 7786 1352. A total distance of approximately 107 metres onto a line leaving a gate at point A on the Order map at grid reference SJ 7775 1351 running in a general south east direction on a stoned/earth surface track with a width of 4 metres. The footpath then leaves the track and continues in a general southerly direction running parallel to and on the western side of the track on a natural surface, with a width of 2 metres to outlet through a gap on Kings Street at point C on the Order map at grid reference SJ 7782 1330. A total distance of approximately 241 metres.
