

**NOTICE OF CONFIRMATION & COMING INTO OPERATION  
OF PUBLIC PATH ORDER AND DEFINITIVE MAP  
AND STATEMENT MODIFICATION ORDER  
HIGHWAYS ACT 1980  
WILDLIFE AND COUNTRYSIDE ACT 1981**

**THE SHROPSHIRE COUNCIL (FOOTPATH 4 (PART) PARISH OF BORASTON)  
PUBLIC PATH DIVERSION ORDER 2025**

On 27<sup>th</sup> November 2025, The Shropshire Council (the “Council”) confirmed the above-named Order made under section 119 of the Highways Act 1980 and section 53A(2) of the Wildlife and Countryside Act 1981. The effect of the Order as confirmed is to;

**divert** the full width of Boraston FP4 (part) commencing from SO 6136 7234, Point A on the Order Map, running in a general SSE, then southerly, then SSW direction to SO 6146 7157, continuing in an easterly direction to meet a footbridge across the Corn Brook at SO 6153 7157, Point C on the Order Map, approximately 930 metres, **onto a line** commencing from the County Road at SO 6136 7234, Point A on the Order Map, and then running in a general SSE direction following an open field boundary, passing around the western edge of a pond, continuing in a general SE, then southerly direction along the field edge to SO 6148 7194, continuing in a general east then SE direction along the field edge to SO 6175 7181, continuing in a general NE direction to where it meets the County Road at SO 6178 7184, Point B on the Order Map, approximately 870 metres with a width of 2 metres throughout.

Shropshire Council certify that the Order became operative on 2<sup>nd</sup> May 2025; but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or any regulation made under the Act has not been complied with in relation to the Order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from 27<sup>th</sup> November 2025 make an application to the High Court.
