

**THE SHROPSHIRE COUNCIL
(PROHIBITION AND RESTRICTION OF WAITING AND PARKING
PLACES) (CONSOLIDATION) ORDER 2009 (B5070, ST MARTINS)
(AMENDMENT) ORDER 2026**

On 5 February 2026 Shropshire Council made an order to introduce the following parking restrictions on the B5070 outside St Martins School:

No Waiting No Loading 8.30 – 9.15 am 2.45 – 3.30pm

B5070 (Outside St Martins School, Southern Side)	From a point 55 metres west of entrance to St Martin's School Car Park in an easterly direction for a distance of 151 metres
B5070 (Outside St Martins School, Northern Side)	From a point 9 metres north-east of the property boundary of Toll Bar Moors Bank and Gas Gov Moors Bank south-westwards for a distance of 87 metres
B5070 (Outside St Martins School, Southern Side)	From the Eastern extent of the property boundary of no. 1 Moors Bank and no. 2 Moors Bank south-westwards for a distance of 65 metres
No Waiting No Loading At any time	
B5070 (Outside St Martins School, Northern side of the road)	From a point 55 metres west of entrance to St Martin's School Car Park in an easterly direction for a distance of 93 metres
B5070 (Outside St Martins School, at the mini roundabout, North)	From a point 78 metres south-west of the property boundary of Toll Bar Moors Bank and Gas Gov Moors Bank westwards for a distance of 42 metres
B5070 (Outside St Martins School, at the mini roundabout, South West)	From a point 12 metres north east from the property boundary of no. 34 Moors Bank and no. 35 Moors Bank eastwards for a distance of 56 metres to the southern property boundary of no. 33 Moors Bank
B5070 (Outside St Martins School, at the mini roundabout, South East)	From a point 65 metres south west from the Eastern extent of the property boundary of no. 1 Moors Bank and no. 2 Moors Bank south-

westwards for a distance of 50 metres

Bus Stop Clearway

B5070

(Outside St Martins School, Northern side)

From a point 6 metres from the exit of St Martin's School Car Park to the full extents of the layby in an easterly direction for a distance of 40 metres

These changes will come into effect on 10 February 2026.

A copy of the order may be examined during normal office hours (8:45am-5:00pm Monday to Thursday, and 8:45am-4:00pm on Fridays) at Shropshire Council, The Guildhall, Frankwell, Shrewsbury.

If you wish to question the validity of the Order, or any provisions in it, on the grounds that they are not within the powers conferred by The Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, you may, within six weeks from 5 February 2026, apply for that purpose to the High Court.
