

Privacy notice – Covid-19 Vaccination Programme

Who we are?

How do we collect information from you?

We collect information from you when you visit the Shropshire Council website also when you contact us in writing, speak to us on the phone, by email or any other type of electronic communication, or talk to us face to face.

What types of information do we collect from you?

We collect different categories of information about you, depending on the service you want from us and/or the reason why we need to process information relating to you. This could be personal information (for example your name and address), or other more sensitive data that we would only collect and use in very particular circumstances that are set out in law.

Details of information obtained from third parties?

For the purposes of the Covid-19 Vaccination programme we receive information from Public Health England and local health bodies as well as your employer.

How is your information used?

Under and in accordance with the current Control Of Patient Information Notice issued by the Secretary of Health to combat the current Covid-19 outbreak. We are using information to support the local Covid-19 vaccination programme for the protection of public health.

We will use your information as follows:

- To update or create your record in the National NHS NIMS (National Immunisation Management System) system to ensure the correct prioritisation for Covid-19 Vaccination.
- We will update NHS booking systems to record that you have been booked in for a vaccination appointment

Research and statistics

Anonymised and pseudonymised data may be used for research & statistical purposes. Any data collected may be used for research and statistical purposes that are relevant and compatible with the purpose that the data was collected for.

Who has access to your information?

We may share your information with the following third parties for the reasons detailed;

- Internal local authority departments involved in providing support or helping to carry out the local Covid-19 Vaccination programme.
- Telford and Wrekin Council departments involved in providing support or helping to carry out the local Covid-19 Vaccination programme.
- NHS both National and local involved in the Covid-19 Vaccination programme.
- Your Employer so that the correct up to date information about you is gathered

We will not sell or rent your information to third parties. We will not share your information with third parties for marketing purposes.

What are your rights in relation the personal data we process?

Access – you can request copies of any of your personal information that is held by the Council.

Rectification – you can ask us to correct any incorrect information.

Deletion – you can ask us to delete your personal information. The Council can refuse to delete information if we have a lawful reason to keep this.

Portability – you can ask us to transfer your personal data to different services or to you in some circumstances.

Right to object or restrict processing – you have the right to object to how your data is being used and how it is going to be used in the future.

Right to prevent automatic decisions – you have the right to challenge a decision that affects you that has been made automatically without human intervention, for example an online form with an instant decision.

How long will we keep your information for?

We keep and dispose of all records in line with our corporate retention schedule. We will comply with Data Protection legislation in regard to how long we keep your data. Currently the time limit for retaining this information is set at Two years to cover the likely period of the vaccination programme.

What security precautions in place to protect the loss, misuse or alteration of your information?

We are strongly committed to data security and will take reasonable and appropriate steps to protect your personal information from unauthorised access, loss, misuse, alteration or corruption. We have put in place physical, electronic, and managerial procedures to safeguard the information you provide to us. However, we cannot guarantee the security of any information you transmit to us. We recommend that you take every precaution to protect your personal information.

Keeping your data up to date

We want to ensure any information we hold is accurate. You can help us by promptly informing us of any changes to the information we hold about you.

Details of any automated decision processes

The data gathering process does not have any automated decision making.
