**THE SHROPSHIRE COUNCIL (FOOTPATH 64, PARISH OF
WORTHEN WITH SHELVE) PUBLIC PATH EXTINGUISHMENT ORDER 2019**

This order is made by The Shropshire Council ("the Council") under section 118 of the Highways Act 1980 ("the 1980 Act") because it appears to the Council that the footpath described in paragraph 1 below is not needed for public use.

This Order is also made under section 53A (2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Shropshire definitive map and statement require modification in consequence of the occurrence of the event specified in section 53 (3)(a)(i) of the 1981 Act, namely, the stopping up (as authorised by this Order) of a highway hitherto shown or required to be shown in the map and statement.

BY THIS ORDER:

The public right of way over the land situate at White House Farm in the Parish of Worthen with Shelve shown by a continuous bold line on the map attached to this order and described in Part 1 of the Schedule to this order shall be extinguished on the date of confirmation of this order and thereupon the Shropshire definitive map shall be modified by deleting from it that public right of way, and upon the occurrence of the extinguishment the Shropshire definitive map shall be modified by deleting from it that public right of way, and the definitive statement shall be modified as described in Part 2 of the Schedule to this order.

1. Notwithstanding paragraph 1 of this order statutory undertakers shall have the following rights over the land referred to in paragraph 1 above, namely:

Where immediately before the date on which the footpath is extinguished there is apparatus under, in, on, over, along or across them belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same right in respect of the apparatus as they then had.

SCHEDULE

PART 1

Description of Public Right of Way Extinguished

The full width of Footpath 64 Worthen with Shelve, to be extinguished from point A on the Order Map (SJ 3008 0434), running in a general north easterly direction crossing Weston Brook and then following a woodland and scrub field margin of a pasture field. It continues as a field edge path to join Footpath 65 at point B on the Order Map (SJ 3046 0460); a total distance of approximately 490 metres.

PART 2

Modification of Definitive Statement

There is no Shropshire definitive statement for Footpath 64, Worthen with Shelve.
