DEFINITIVE MAP AND STATEMENT OF RIGHTS OF WAY FOR SHROPSHIRE

THE SHROPSHIRE COUNCIL (FOOTPATH & RESTRITCED BYWAY ADDITIONS, PARISH OF CLUNBURY) MODIFICATION ORDER 2024

This Order is made by The Shropshire Council ("the Council") under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the Council that the Shropshire Definitive Map and Statement require modification because in accordance with the provisions of Section 53(3)(c)(i) the Council has discovered evidence which (when considered with all other relevant evidence available to them) shows -

that a right of way which is not shown on the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, a restricted byway or, subject to section 54A, a byway open to all traffic

The Council hereby order that:-

- 1. For the purpose of this Order the relevant date is 29th January 2024.
- 2. The Shropshire Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the maps attached to the Order.
- 3. This Order shall take effect on the date it is confirmed and may be cited as The Shropshire Council (Footpath and Restricted Byway Additions, Parish of Clunbury) Modification Order 2024.

Modification of Definitive Map

Description of paths or ways to be added

Footpath Addition - Order Map 1

A footpath to be added from point A on Order Map 1 where it leaves the County Road (SO 3362 8136), running in a general northerly direction along a metalled surface and through a field gate, for approximately 42 metres, to meet a pedestrian wicket gate. It then runs along a grass surface in the same general northerly direction for approximately 80 metres to meet a wooden pedestrian wicket gate. It then continues on the same grass surface for approximately 88 metres to meet a field gate, and then continues along the same surface and in the same general northerly, then north-north-westerly direction for approximately 108 metres to meet a stile at point B on Order Map 1 (SO 3357 8167). It has a total length of 318 metres and a width of 2 metres throughout.

Restricted Byway Addition - Order Map 2

A restricted byway to be added from point A on Order Map 2, where it leaves the County Road (SO 3365 8136), running in a general northerly direction along a metalled track for approximately 108 metres. It then continues on a natural surface in the same general northerly direction for approximately 155 metres, before curving to run in a general northwesterly direction for approximately 108m. From there it runs on a metalled surface for approximately 29 metres in a general westerly direction, to meet the County Road at Point B on Order Map 2 (SO 3353 8169). It has a total length of 400 metres and a width varying between 4 and 9 metres.

A stile is located at grid reference SO 3357 8167

<u>Modification of Definitive Statement</u> Description of paths or ways to be added

Footpath Addition - Order Map 1

A footpath to be added from point A on Order Map 1 where it leaves the County Road (SO 3362 8136), running in a general northerly direction along a metalled surface and through a field gate, for approximately 42 metres, to meet a pedestrian wicket gate. It then runs along a grass surface in the same general northerly direction for approximately 80 metres to meet a wooden pedestrian wicket gate. It then continues on the same grass surface for approximately 88 metres to meet a field gate, and then continues along the same surface and in the same general northerly, then north-north-westerly direction for approximately 108 metres to meet a stile at point B on Order Map 1 (SO 3357 8167). It has a total length of 318 metres and a width of 2 metres throughout.

Restricted Byway Addition -- Order Map 2

A restricted byway to be added from point A on Order Map 2, where it leaves the County Road (SO 3365 8136), running in a general northerly direction along a metalled track for approximately 108 metres. It then continues on a natural surface in the same general northerly direction for approximately 155 metres, before curving to run in a general northwesterly direction for approximately 108m. From there it runs on a metalled surface for approximately 29 metres in a general westerly direction, to meet the County Road at Point B on Order Map 2 (SO 3353 8169). It has a total length of 400 metres and a width varying between 4 and 9 metres.

A stile is located at grid reference SO 3357 8167


